<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p>For <a href="#">network providers</a> \$4,500 individual / \$9,000 family. <a href="#">Out-of-network providers</a> \$13,500 individual / \$27,000 family.</p>	<p>Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a>, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a>.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. For example: In-network <a href="#">preventive care</a>, primary care, <a href="#">specialist</a>, <a href="#">urgent care</a>, virtual visits, outpatient mental health and substance use disorder, outpatient rehabilitation and habilitation, and children vision services, as well as in and out of <a href="#">network</a> prescription medications are covered before you meet your <a href="#">deductible</a>.</p>	<p>This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. You will pay less if you use a <a href="#">provider</a> in the <a href="#">plan's network</a>.
